**Statistics for BE:** Please note that: 1) The total number of third country nationals (13) refers to the (non-EU) persons entered in the procedure but not yet formally identified as smuggled persons, and 2) the 127 convictions for smuggling in human beings reported in 2016 relate to the incrimination for smuggling in human beings which includes the financial gain as an element of the definition. Besides this the Belgian law foresees another incrimination sanctioning people facilitating irregular migration (stay, transit, residence).

**Statistics for CZ:** 30 persons in total were prosecuted in relation to facilitation of irregular migration:

14 persons for assisting in unauthorised stay in the territory of the Czech Republic and 16 persons for organising and facilitation of unauthorised crossing of state border. 41 persons were convicted for facilitation of irregular migration: 11 persons for assisting in unauthorised stay in the territory of the Czech Republic + 30 persons for organising and facilitation of unauthorised crossing of state borders.

**Statistics for FR:** The number of third-country nationals identified as smuggled persons is not recorded by the Central Directorate of Border Police (only number of smugglers and networks are recorded). The number of residence permits granted to smuggled persons is not recorded (residence permits are recorded for victims of trafficking. 1499 persons were sued and 1186 persons convicted for facilitating illegal entry and stay (figures for 2015).

**Statistics for NL:** • Smuggled persons: on this list the number of smuggled persons is less than the number of apprehended smugglers. Firstly, this list only concerns figures from the Royal Netherlands Marechaussee. There is no information is available from the National Police on this subject. Secondly, the role of the smuggled persons is not always properly recorded in our information systems; therefore the numbers are not fully complete. .

• Number of reflection periods: we do not record any information of these numbers in our information systems.

• Number of arrested smugglers: the results of the National Police are included within these numbers. They have arrested a total of 97 smugglers.

• *Number of convicted human traffickers: this number is not related to the number of arrested suspects. The investigation and prosecution of human traffickers often is a lengthy process. This number can therefore relate to findings in 2015, which only lead to conviction in 2016. Additionally, a part of the number of arrested human traffickers will appear in court in 2017.*

Statistics for NO: Numbers are per 28<sup>th</sup> April 2017 and are not final numbers for 2016.

Statistics for SE: In 2016, Swedish Police accused a total of 225 persons of smuggling third-country nationals into Sweden. If a suspected smuggler is a Swedish resident, he/she is normally not arrested or detained. Swedish authorities assume that most people coming to Sweden to apply for asylum have made use of facilitators/smugglers to enter European Union territory.

Statistics for SK: \* The number of persons suspected from migrant smuggling as a criminal offence. \*\*The number of persons against whom criminal prosecution was started.

Nor can gender and minority be distinguished yet.
